## LOCATION

TJ's Customs Inc. and FunFest Productions are joining forces, presenting the fourth annual Stars and Stripes Festival and Fine Art Show. With Fun Fest Production expertise in mounting large scale events, the Stars And Stripes Festival provides a wide variety of experiences to guests, last year drawing well over 520,000 visitors. The Art Show will be located on Macomb Place which is one of the major streets running through the festival. The festival takes place in picturesque Downtown Mt. Clemens. The festival will include a fine art show, firework on Friday night, children's activities, food vendors and live national and local entertainment. Admission to public is free.

## MEDIA

Paintings, sculptures, pottery, jewelry, fiber, photography, glass, graphics, metal, wood and other medias. All work must be original—no kits, patterns, commercial products, imports or copies allowed. Work not in good taste or not acceptable will be asked to be removed.

## FEES

Exhibiting art space \$250.00 per space, Double spaces available for \$475.00, plus \$25.00 nonrefundable application fee (submit separate checks payable in U.S. funds). Upon acceptance, Booth fee is nonreturnable. Limited corner spaces available for \$25.00, separate check. Free electricity will be available. Deadline is March 15th 2010. Late entries will incur a \$25.00 late fee. Notice of acceptance or rejection will be mailed or emailed by March 30th.

## JURING

This is a Juried fine art & craft show. Exhibitors will be juried on the quality and originality of their work. All decisions of the jury are final.

## ARTIST REGULATIONS

- Artists will be assigned their spaces on Thursday, July 1st. Artists must be open and ready to sell by 11 a.m. on Friday, Saturday, Sunday & Monday. Artists must remain open until 11 p.m. on Friday, Saturday, and Sunday, and on Monday until 8 p.m. . NO EXCEPTIONS. Artists must oversee their exhibits at all times and display their work for the duration of the show. Assistants, including family members are welcome, but NOT in place of the artist.
- Cash awards and ribbons will be presented. \$500.00 for best of show, \$250.00 for first place, \$150.00 for second place , \$100.00 for third place and \$25.00 for honorable mentions.
- Submit three digital photographs representative of your work and one of your entire display on a CD as a jpg files. Artist's name, media and size of work must be clearly printed the front of each CD, 35mm Slides will also be accepted.
- Please provide a very brief statement (one paragraph) that describes the materials and techniques used to create your work.
- Booth sharing is not permitted with the exception of collaborating artists. Collaborations must be artistic rather than business. A team producing a single product may qualify as a single exhibitor. However, such a team may consist of no more than two people. If two names are on the application, both artists must sign the application, check in, and show I.D.
- Artists may exhibit their work only in the categories in which they are accepted.
- All booths and their contents must be furnished by the artist, be able to withstand crowds and weather, and fit within a 10'x12' or 10' x 24' space. Festival organizers may ask an exhibitor with an unsafe display to correct the problem, or will be asked to leave and forfeit all fees.
- Only work represented by submitted images can be exhibited. The festival organizers reserve the right to refuse exhibition of work that is not consistent with the artist's submitted images.
- Artists are responsible for collection and reporting of all taxes, including 6% Michigan sales tax.
- Artist is responsible for proper insurance.
- No generators will be permitted.
- Sales of silkscreened and iron-on T-shirts and CD's are prohibited.
- Open to all artists 18 years and older.
- No Pets Allowed. No Alcoholic beverages and / or drugs allowed.
